The Terms of The Declaration

<Obligation to comply with regulations>

Participants are reminded that the event is not a timed race, but a cycling event on public roads, and that they are responsible for their own safety and health. Participants are responsible for their own safety and health, and will participate in the event after confirming the precautions described in the "Recruitment Guidelines". In the event of disqualification by the organizer, I will follow the instructions of the organizer. I pledge to immediately cancel my participation in the event that I should develop any physical or other health problems.

<Understanding the characteristics of the competition and ensuring safety>

Participants are experienced cyclists and are fully aware that the event is held in a changeable natural environment and that the physical condition of participants can change rapidly. They are also well aware that the course will be wide open, which will likely hinder first aid or response in the event of an emergency.

<Bicycle Maintenance Obligations>

In order to prevent accidents due to poor bicycle maintenance, participants must have their bicycles inspected prior to the event in accordance with the "Bicycle Inspection Certificate" specified by the organizer and submit the "Bicycle Inspection Certificate" at the registration desk.

<Self-assessment of health status>

As a participant, you are in good health and do not anticipate any problems with your participation in the convention. If you have any medical emergencies due to allergies, hypersensitivities, or pre-existing medical conditions, or for religious or other reasons, we will inform the organizers in advance.

<Acceptance of self-management responsibility and first aid>

Participants pledge to participate in the event with due care for their own safety and health, and to take full responsibility for any accidents that may occur during the race, regardless of the cause, and not to hold the organizers or other responsible parties liable. In the event that the organizer determines that there are obstacles to the continuation of the event, the organizer will accept the recommendation to cancel the event. In the event that a participant is injured, suffers an accident, or becomes ill during the event, the participant agrees to accept that treatment will be given to the participant and will not object to the method or outcome of such treatment.

<Coverage for accidents resulting in injury or death>

In the event that a participant is injured, suffers permanent injury, or dies as a result of an injury sustained during the event or any of the ancillary events, regardless of the cause, the participant releases all persons involved in the event from any and all liability to the organizers. The Participant further acknowledges and agrees that compensation for the Participant shall be covered by the personal accident insurance policy in force at the time of the event. Accordingly, the participant hereby releases himself/herself, his/her executors, administrators, heirs, next of kin, etc., from any and all claims, suits, and demands for payment of attorney's fees and costs for any and all injuries sustained by the participant.

<Disclaimer>

Participants pledge that they will not hold the organizer responsible for any event cancellation or change in the event that the event is cancelled due to reasons beyond the control of the organizer, such as worsening weather conditions or poor running conditions, or if they are prevented from participating in the event due to loss or damage of equipment, and that they will not make any claim for payment of expenses (including participation fees) incurred for participating in the event.

<Portrait Rights and Handling of Personal Information>

Participants understand that their personal information, including their portrait, name, address, age, competition history, and self-introduction, may be used on the website created by the organizer, in the event brochure, in publicity materials related to the event, and in the press and information media, and they consent to the commercial use of such information in printed materials, videos, and information media produced by the organizer in connection with the event.

<Handling of Personal Information>

The participant agrees that the personal information provided in the application form will be used only to the extent necessary to communicate with the organizer and to complete the procedures for participation in the event. In addition, the Participant consents to the use of his/her personal information for information related to other sporting events conducted by the organizer and the sponsoring constituent organizations.

<Matters not specified in this Pledge>

In the event of any dispute concerning the interpretation of this agreement, the parties agree to resolve such dispute in accordance with the rules and regulations governing the tournament. In the event that any dispute arises regarding the tournament, the Kyoto District Court will have exclusive jurisdiction in the first instance, and it is agreed that the laws of Japan will govern.

<Obligation to purchase bicycle insurance>

In Kyoto Prefecture, the "Ordinance on the Promotion of Safe Bicycle Use" requires the purchase of bicycle insurance in order to provide relief to victims of personal injury accidents and to reduce the financial burden on the offender. (Foreign participants are also required to have bicycle insurance in their own countries.)
